ABOUT THE OPPORTUNITY:

The selected Scholar will participate in an immersive ten-week clerkship, spending the first six weeks as a Summer Associate in Dickinson Wright’s Chicago office and the following four weeks as a legal intern within the legal department of JP Morgan Chase. This clerkship provides a rising 2L the unique opportunity to work alongside a wide array of Dickinson Wright attorneys and gain in-house experience with one of our Firm’s key clients. While exact dates are to be determined, the program will likely commence on May 22, 2023 and conclude on July 28, 2023.

The Scholar will also:

1. Participate in traditional summer associate activities with Dickinson Wright and in LCLD’s Summer Scholars programming,
2. Be assigned a DW junior and senior mentor for the duration of their time with DW,
3. Receive substantive work assignments from both DW and JP Morgan Chase to develop the Scholar’s skills.
4. Receive meaningful and constructive feedback on assignments.

ELIGIBILITY:

Students who meet the following criteria are eligible to apply for this opportunity:

1. Currently enrolled as a first-year law student in good standing at an ABA-accredited law school,
2. Self-identify as racially or ethnically diverse, LGBTQ, or as a person with a disability, and
3. Legally eligible to work in the United States.

Ideal applicants will also possess strong legal writing, analytic, interpersonal skills.

All Applications Must Include:

1. A resume,
2. A law school transcript,
3. A cover letter, and
4. A writing sample
